President's message

Hello, dear members.

I am writing this a few days after the Annual Meeting of Members held in Gatineau from June the17th to the 20th. It was attended by the presidents of 79 branches or their representatives, as well as by numerous observers.

There were many talks and presentations, but the most significant items came up in the resolutions. I will discuss several of the most important.

A five-year (2019-2024) strategic plan was approved unanimously. It is available on the Association's national website at https://www.federalretirees.ca/sites/default/files/2019-04/draft_strategic_plan_2019-2024.pdf While the link indicates that the strategic plan is a draft, it has been adopted.

A motion to create a support fund for the branches led to much discussion, not because it lacked merit, but because participants wondered what would be done with amounts that were not spent. It was finally decided to establish a fund of \$80,000 and to maintain that amount each year. If any money is not used, it will be rolled over into the following year and additional money will be allocated to keep the fund at \$80,000. The fund will go for projects which will have to be approved, and the amounts spent will have to be accounted for.

A motion on membership fees was debated at length before finally being approved. Fees will rise at a rate based on the increase in the cost of living. As a result, these will go up by 2.2% in 2020. It is important to note that the same rate will be used for returns to branches. Quebec presidents, myself included, were opposed to this increase without a financial analysis.

A motion on the code of conduct modifying a sentence on illicit substances was also adopted unanimously. The new sentence reads: "Members shall not conduct Association meetings or represent the Association if impaired by any substance."

Finally, a motion modifying regulation 5.5, which deals with our preferred partners, was also adopted unanimously. This was the result of many discussions, especially with the Quebec branches. It will make it easier to designate preferred partners appropriate to the branches. Other, less important, resolutions were also adopted.

James Nicholson, from the Quebec branch, was reappointed without opposition to one of the two Director positions of the District of Quebec. The other position is held by Jacques Lambert from the Montreal branch.

On a personal note, I received the Collaboration Award at the Volunteer Recognition Dinner. Needless to say, I am extremely proud. Speaking of recognition, I would like to acknowledge the work of our employees Danielle, France and Josée, as well as the help provided by volunteers. Let me add that volunteers are always welcome in our committees – recruitment, member retention, communications, translation (English to French), etc. If you'd like to get involved, get in touch with our office.

I believe you have noticed that our four-page insert in SAGE magazine has been greatly improved.

We will be in touch again in the Spring. Until then, I hope to see you at the Christmas dinner. I wish you good health.



Your Montreal Branch needs members

Our members are elderly: more than 20 % are older than the average life expectancy for those born the same year, that is, older than statistics would indicate. In the short term this means that across Canada, up to 45,000 of our 173,000 members might pass away. Our Association needs new members to assure its continuity.

The usual tools used in our membership drives – letters distributed by the Pension Centre and presentations during pre-retirement courses on the services we offer – were eliminated by our Government. As a result, our Association focused on retaining and adding to its membership in the 2018 strategic plan.

This requires:

- 1. Understanding the particular characteristics our various member groups (for example, the Canadian Armed Forces);
- 2. Using alternative ways of making ourselves known (new marketing techniques);
- 3. Improving our efforts to retain members.

Part of the challenge in attracting members is that it is very hard to separate federal pensioners from all Canadian pensioners. That is why we are asking for your help. You can also let your acquaintances know that the main objective of our association is the financial security, the buying power, of our retirement pensions. People think that our pensions have always been indexed. That is not the case.

Indexation was obtained only in 1973, thanks to the efforts of the Association. This year, City of Montreal pensioners received 0% and provincial pensioners 0.6%, while we got a raise of 2.2%. This means more money left in our pockets after we buy our groceries. Do not believe that a future government will not consider taking indexation away. We have to be vigilant. There is strength in numbers.
